President's Report

For some educational information, Nancy talked about and read excepts from the article "Spay, Neuter and Joint Disease," by Dana Scott. Primarily highlighted issues with early spaying, such as abnormal growth, hip dysplasia, osteosarcoma & risk for cancer. Finding that the same hormones for reproduction affect growth. Suggested a two year minimum before spaying/neutering.

Vice President's Report

Kevin passed out copies of drafts for three bills going up for review at the 64th Legislative Assembly of North Dakota in the House.

House Bill 1191: renters can be asked by a landlord to request documentation for service or assistance animals.

House Bill 1192: landlords can charge a pet security deposit no greater than \$2500 or two months of rent.

House Concurrent Resolution 3010: identification of a legitimate service/assistance animal to distinguish them from companion animals.
