Meeting Called To Order at 1:33 p.m.

Approval of Minutes: Correction to the February minutes,

Motion to correct the minutes. 1st by Barb, 2nd by Myra, Motion approved.

President's Report: Educational & Show stuff as follows

Educational: Discussion of a House Bill up for review in Montana. <u>H.B. 608</u> "Montana Commercial Pet Protection Act". Establishing a board of Commercial Pet Breeders, Licensing, Inspections, Revenue & Penalties, etc. Part of the bill of concern in the definition of a commercial breeder as follows:

(5) "Commercial breeder" means an individual, entity, association, trust, or corporation engaged in the business of breeding dogs or cats that:

(a) owns, keeps, or harbors eight or more intact dogs or cats that are used for breeding; or

(b) sells, exchanges, leases, or transfers or offers to sell, exchange, lease, or transfer 31 or more dogs in a 12-month period beginning January 1 of each year.

The "or" is a matter of concern due to it affecting shelters, rescues, and humane societies and those that foster for them. Also the board would have among them a representative each from a humane society and an animal shelter. If passed, as is, could lead to legislation elsewhere in the country of similar restrictions.

Vice President's Report:

Update on House Bills:

- <u>H.B. 1191</u> passed 88-5, now up for Senate vote.
- H.B. 1192 passed 90-0, went up for Senate vote.
- <u>H.C.R. 3010</u> amendment adopted, now up for Senate vote.
